 Regulations for the Subsidy of 2022 Research Ethics Review Fee
 Implemented against the approval of Principal on 2022/4/15

I. Purpose

In order to assist teacher, research fellow and students who implement human research project in accordance with review regulations without subsidy as well as encourage the application of research ethics review for human research project to exercise social responsibility to exercise the social responsibility in term of protecting research participants, National Taiwan Normal University (hereinafter the NTNU) hereby establishes these regulations.

II. Responsible Unit: Research Ethics Office, Office of Research and Development of NTNU

III. Scope of Application

The regulations are applicable for persons who are satisfactory to conditions as follows:

- (1) The research project of full-time teacher and research fellow or student (including doctoral or graduate student) of NTNU
- (2) The receipt of ethics review fee of research project applied shall be in the period from January 1 to November 30, 2022.
- (3) The application unit for research ethics review shall be the Research Ethics Review Committee of NTNU.
- (4) The research project is without any subsidy and the principal investigator or student shall pay for the research ethics review fee because it cannot be reimbursed in other research project.

IV. Subsidy standards and quota

Review Category	Original Review Fee	Amount of Review Fee of Teacher, Research Fellow and Student after Receiving the Subsidy (NTNU Subsidy Amount)
Full Board Review	19,500	6,000 (NTNU subsidy 13,500)
Expedited Review	14,500	4,500 (NTNU subsidy 10,000)
Exempt Review	2,500	1,000 (NTNU subsidy 1,500)

*The subsidy standards are only applicable to new project in the list, which are unavailable for subsequent review project.

*This subsidy shall be one person one project in general.

V. Application deadline: now until November 30, 2022. The application beyond the deadline will be rejected. If the budget is out, the suspension of application will be

announced.

VI. Application procedures:

1. For new project application, please pay the research ethics review fee first, which shall be applied to forward of risk category.
2. After receiving the result of budget contribution to research project of each unit, please confirm the research ethics review fee reimbursement with relevant unit first.

(Note: according to the regulations of Department of Humanities and Social Sciences, NSTC, the project host without receiving subsidy may apply additional budget for existed keynote project of Department of Humanities and Social Sciences, NSTC to reimburse the research ethics review fee)

3. If the project host or student needs to pay the review fee because there is no subsidy received and no other research project available for the reimbursement of research ethics review fee, the project host or student may apply for this subsidy.
4. Please submit application and required documents to Research Ethics Office:
 - (1) Teachers and research fellows:
Please fill “Application for 2022 Subsidy of NTNU Teacher and Research Fellow Research Ethics Review Fee”
 - (2) Students:
Please fill “Application for 2022 Subsidy of NTNU Student Research Ethics Review Fee”
5. The Research Ethics Office will notice the applicant for checking results via email after receiving the application and manage the subsidy distribution upon the approval of Research Ethics Office for the budget.
